INSTRUCTIONS/ACCEPTABLE DOCUMENTS

All supporting financial documents must be **in English** or accompanied by a notarized English translation showing available **liquidable funds**. The financial documents cannot be older than **three months** at the time of submission to Salve Regina University in order to be considered valid. Appropriate documents reflecting financial ability include, but are not limited to, the following:

Bank Letter, stamped and signed by a bank official, and specifies the date, monetary currency, and name of the account holder.
Salve Regina University scholarship award letter (if applicable)
Signed letter from the U.S. Government, Home Government, International Organization, Company, or Employer on government or organizational letterhead specifying dates, amount, monetary currency, and terms of sponsorship.
An individual sponsor who is not a U.S. citizen, U.S. Permanent Resident, or non-immigrant legally present in the U.S., mus sign the Certification of Finances Form and attach supporting financial documents.
 An individual sponsor who is a U.S. citizen, U.S. Permanent Resident, or non-immigrant legally present in the U.S., must submit a completed <u>I-134 Affidavit of Support Form</u> with supporting financial documents. <u>Please Note</u>: Under item #7, please do not submit a copy of your last income tax return. You can access the form here: http://www.uscis.gov/sites/default/files/files/form/i-134.pdf Affidavit of Support (must be signed by everyone who is sponsoring the student) Affidavit of Housing Support (if the student will live with a sponsor in the U.S.)
