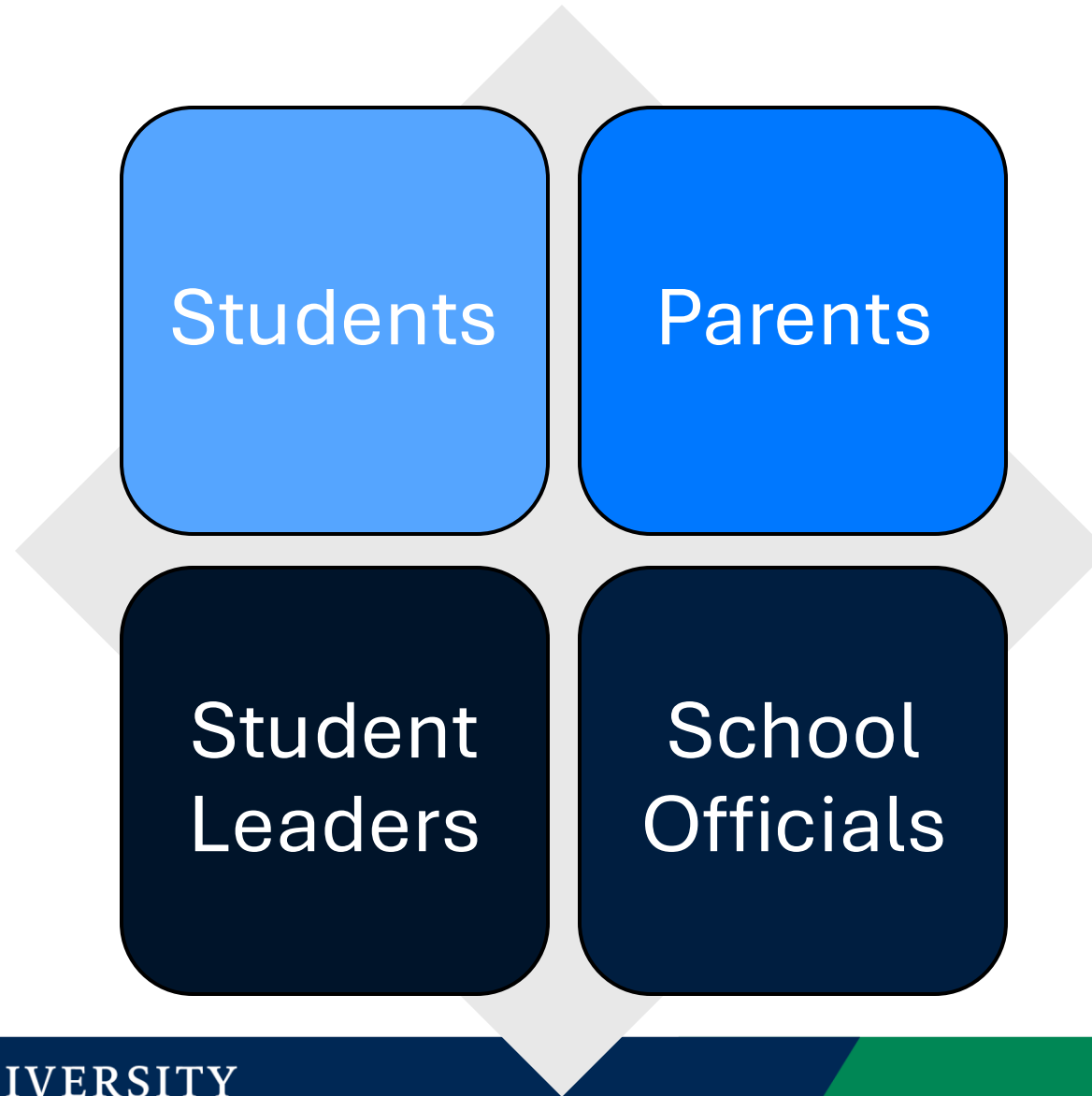

Access to Student Information

- *Regardless of age, once a student starts college, access rights transfer from the parent to the student.*
- *Information can only be released to an individual when there is a written request from the student.*
- Students may sign a FERPA release form to grant permission to discuss their student record. We will review FERPA and how to access forms at New Seahawk Orientation.

Private “Protected” Info

- Grades
- Transcripts
- Student course schedules
- Student financial information
- Texts, emails, written notes

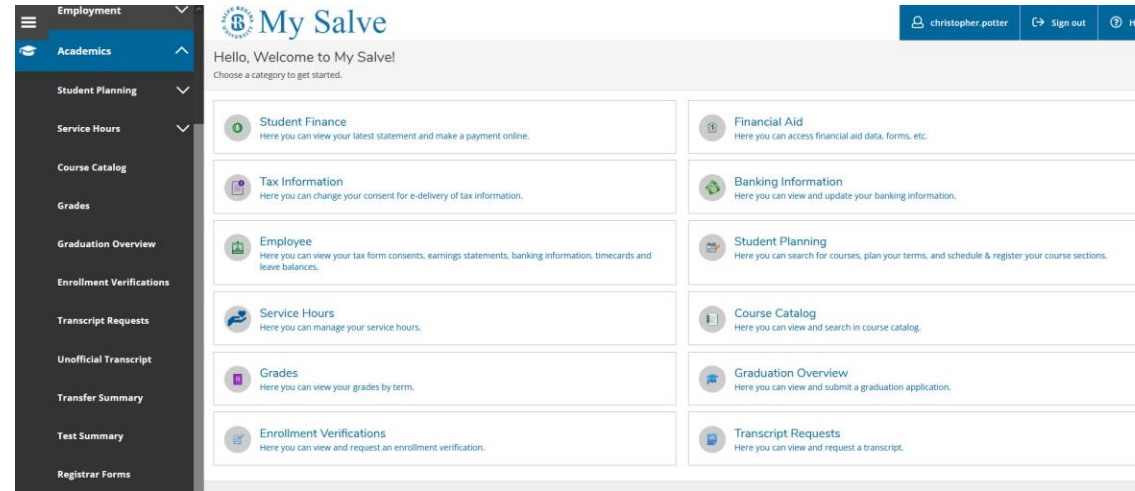
May not be published or provided to anyone unless the student provides written permission

Student's parents/guardians had the right to access academic records while in high school.

In college, parents/guardians may not access records without written permission from student.

Forms

Students complete a FERPA Release Form for each person they are granting permission to speak with university officials about their record.



- Forms are online and may be accessed from My Salve

- Students indicate if designated person should have access to financial or academic information.
- The person may be a parent, guardian, partner or anyone the student designates.

- ✓ Update changes to the student record. For example, address, change of major, and minor updates

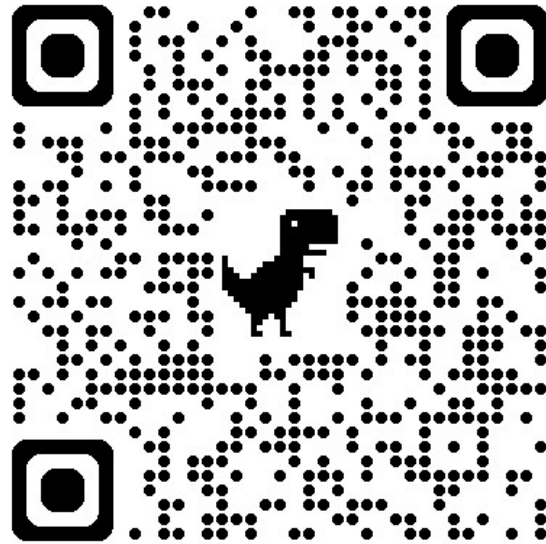
