The program is directed toward developing leaders with a focus on ethics, organizational behavior, finance, economics, accounting and strategic management. MBA Program Requirements

The MBA degree prepares professionals to lead and manage organizations with skills in operations, finance, accounting, economics and strategic management.

Prerequisite Courses:

Students are required to demonstrate successful completion of the following undergraduate courses:

- 6 credits in Accounting
- 3 credits in Economics
- Quantitative Analysis; and Calculus or Statistics (6 credits)

Prerequisite course equivalencies may be demonstrated by one or more of the following methods:

- (1) Official undergraduate transcript from an accredited institution demonstrating successful completion of the prerequisite courses
- (2) CLEP examination results demonstrating proficiency in the prerequisite courses

Admission Requirements

Individuals with a bachelor's degree in any undergraduate major from a regionally accredited college or university (or an equivalent degree from an accredited institution outside of the United States) may apply to this program.

Application materials are submitted online at salve.edu/grad. There is no fee to apply. Salve Regina University evaluates the total application package; you must submit the following to be considered:

- Completed graduate application
- Official transcripts from each college/university attended
- Personal statement
- Two professional letters of recommendation
- Resume

Students must successfully complete 12 courses totaling 36 credits to earn the MBA degree. All MBA students must complete the following core curriculum of 10 courses (30 credits):

Students must also complete two elective courses (6 credits) by combining selections from any of Salve Regina University's graduate course offerings.

Concentrations

Elective courses may be combined into an area of concentration (minimum of 9 credits required). The following concentrations are available:

Cybersecurity Issues in Business

The concentration in cybersecurity issues in business addresses the cyber threats that face many organizations. Awareness of threats and managing risks work to decrease vulnerabilities and exposure that left unchecked, may damage an organization's brand, credibility and value.

Nonprofit Management

This concentration focuses on administrative positions in nonprofit fields such as healthcare, education, social welfare, labor unions, museums, historic sites, libraries and fraternal, professional, performing arts, environmental and cemetery organizations.

Social Ventures

Social ventures are business units focused on providing social benefit and solutions to social problems. For-profit or not-for-profit, the focus is on providing positive impact on social issues in a sustainable manner.

Entrepreneurial Enterprise

Students in the entrepreneurial enterprise concentration complete courses designed to develop creative thinking, opportunity analysis and support, business plan development and strategic planning.

Healthcare Administration and Management

Students who concentrate in healthcare administration and management complete healthcare-specific courses in marketing, law, ethics, health policy and finance.
